## RULES AND REGULATIONS

1. NAME OF THE ASSOCIATION : VAMSI KRISHNA EDUCATIONAL SOCIETY,  
D No: 7/49, Near Chowdeswari Temple,  
Gandhi Nagar, DHARMAVARAM-515671.

2. LOCATION : GANDHI NAGAR, DHARMAVARAM.

3. MEMBERSHIP :

The person who wants to enroll as member in the Society, he has to be paid Rs. 500/- towards membership, and also to be paid Rs. 25/- towards monthly subscription. The person who fails to renew his membership before the end of three succeeding months, automatically ceases to be a member. No member shall be entitled to vote whose subscription shall have been in arrear for a period not exceeding three months.

4. GENERAL BODY AND ITS FUNCTIONS:

- i) To elect executive body or managing committee;
- ii) To pass budget for ensuing year and approve the expenditure statement of the previous year;
- iii) To approve the report of the activities of the Society;
- iv) To appoint an Auditor.

5. EXECUTIVE BODY:

The Executive body shall consists of 07 (SEVEN) members of which the President, the Secretary and one person elected by the General Body to have over all supervision over the day today administration.

6. MEETINGS:

- i. The General Body shall meet once in a year in the month of APRIL and the elections for the general body shall be conducted every three years to elect office bearers;
- ii. Extra-ordinary meetings of the General Body may be convened at any time when called for by the Executive Body within 10 days notice to all members.
- iii. The Executive body will meet once in a month or earlier if there is need for it.

7. QUORUM:

The quorum for Executive body shall be 2/3(Two Thirds) present and voting.

## **DUTIES OF OFFICE BEARERS:**

### **i. PRESIDENT:**

The President shall preside over all the meetings of the General Body, Governing Body and Sub-committee. He shall have the right to call for emergency meeting for transaction of the urgent matters if any. He can sanction expenditure to the extent of Rs. 3,000/- at a time in an year subject to subsequent sanction in Governing body. He shall operate the Bank account of the Society jointly with the Secretary.

### **ii. VICE-PRESIDENT:**

In the absence of the President he shall perform the functions of the President.

### **iii. SECRETARY:**

The Secretary shall be Chief Executive shall be incharge of the Management of the Office of the Association. He shall convene meetings of the General Body. He shall prepare the agenda for the meetings in consultation with the president. He shall maintain the minutes of the proceedings of all the meetings. He shall carryout the resolutions passed by the General Body. He has to place before the Governing Body every year the revised budget of the academic year. He shall maintain all the Registers and Accounts of the Association. He shall operate the Bank accounts of the Association. He can sanction expenditure to the extent of Rs. 3,000/- at a time in a year subject to the subsequent sanction of the Governing body. He shall look after day today administration of the Association.

### **iv. JOINT SECRETARY:**

He shall assist the Secretary.

### **v. TREASURER :**

The Treasurer shall be the Chief Custodian of funds of the Society. He shall be incharge of all cash and finance of the Society. He shall operate the Bank account of the Society jointly with the Secretary. He shall maintain such accounts as they are prescribed by the Governing Body.

### **8. a. SUIT:**

The Association may sue or sued in the name of the Society.
